**II. ELIGIBILITY:**

Candidates who secured the Cut-Off marks and more in the NEET-UG 2022 conducted by NTA for the year 2022 and fulfilled the following eligibility criteria for admission into MBBD and BDS Courses have to submit their online application by paying the non-refundable application and processing fee including verification fee through online and upload the relevant scanned original certificates/documents and images of photo / signature required for Management Quota seats.

**1) Cut-off Scores in NEET-UG – 2022:**

Category	Qualifying Criteria	Cut off score (out of 720)

NOTE: \*LOWER PERCENTAGE / PERCENTILE OF MARKS FOR SC / ST / BC / OBC / PWD IS ONLY FOR CUT OFF SCORE FOR ELIGIBILITY.

## **2) Qualification:**

- i) Candidates should have passed Intermediate (10+2) or its equivalent examination, i.e. qualifying examination, securing not less than 50% of marks taken together in Physics, Chemistry, Biology (Botany, Zoology) / Bio-technology, 40% marks in case of OBC/BC/SC/ST, are eligible for admission into MBBS/BDS Courses and they have to fulfill other relevant conditions laid down in these regulations as per NMC (erstwhile MCI)/ Dental Council of India guidelines.

**\*Lower percentile of marks for SC/ST/BC/PH is only for eligibility purpose and will not be applicable for reservation as there are no reservation quotas for these categories. Caste certificate issued by other state Governments will be considered for determining their eligibility for cut-off scores.**

## **3) Age:**

Candidate should have completed 17 years of age as on 31-12-2022. Candidate who does not complete 17 years as on 31-12-2022 are not eligible and need not apply.

**A)** Candidates from all over the country are eligible for admission into Management Quota [Category-B and C(NRI)] seats in UG Medical and Dental Courses as per National Medical Commission (erstwhile MCI)/ Dental Council of India / Dr. NTRUHS regulations, provided

- i) **Category-B seats (35% of Intake)** are further categorized as B1 and B2 for which the candidate should be an Indian National, provided
1. **B1 -15% of Category – B seats** are open to the candidates from all over the Country and filled first by order of merit from the merit list of Management Quota seats.
  2. **B2 -85% of Category – B seats** shall be allotted to local candidates of Andhra Pradesh State only i.e. by order of merit from the merit list of Management Quota seats.
- **Please read Prospectus / Regulations carefully regarding explanations on local candidates of Andhra Pradesh State.**

**NOTE:** As per G.O.Ms.No.255, HM & FW (C1) Department, dated.11.10.2022, the Government of Andhra Pradesh issued amendments to the A.P. Un-aided Non-Minority Professional Institutions (Regulation of Admissions into Undergraduate Medical and Dental Professional courses) Rules, 2007 which reads as follows:

### **AMENDMENT**

In rule 3 of the said rules, for clause (a), the following shall be substituted, namely, -

“(a) Nationality and Domicile: The candidates should be Indian Nationals and should satisfy Local, Non-Local status requirement as laid down in the Andhra Pradesh Educational Institutions (Regulation of Admission) Order, 1974 as amended in G.O. (P) No.646 Education (W) department, dated 10.07.1979.

Provided that, Persons of Indian Origin (PIO) /Overseas Citizen of India (OCI) Cardholders are eligible for admission only against any Non-Resident Indian seat or any supernumerary seat;

Provided further that, the OCI Cardholder shall not be eligible for admission against any seat reserved exclusively for Indian Citizens.”

**B)** Foreign Students / OCI Card Holders including PIO / NRI or Children / under Guardianship of NRI, who secured cut-off score and more in NEET-2022, are eligible for admission into MBBS and BDS Courses under Management Quota Category – C (NRI) Seats in Private Un-aided Non-minority/ Minority Medical and Dental Colleges.

**C)** Candidates opting for NRI Category seats in Sri Padmavathi Medical College for Women (under SVIMS), Tirupati are informed to visit SVIMS Website: <http://svimstpt.ap.nic.in> for fee particulars for NRI Category Seats. The seats will be filled as per the Government Orders in this regard.

11.	<b><u>For Overseas Indian Citizen / Persons of Indian Origin / Foreign National</u></b>  <u>Documentary Proof of Citizenship:</u> * Scanned copy of the first and last page of the Passport wherein the Citizenship / Nationality of the Candidate, as well as the date of issue, Validity Period, place of issue, and Issuing Authority of the Passport, are clearly mentioned.  OR * Citizenship Certificate issued by the Competent Authority in the Country of Nationality of the Candidate, wherein the Citizenship /Nationality of the Candidate, date of issue, Validity Period, place of issue, and Issuing Authority, are clearly mentioned.  OR * Any other Document issued by a Government Authority in the Country of Nationality of the Candidate (including OCI Card issued by the MHA or concerned Indian Diplomatic Mission in case of OCT Candidate only), wherein the Citizenship /Nationality of the Candidate, date of issue, Validity Period, place of issue and Issuing Authority of the Document, are clearly mentioned.

**IV. INSTRUCTIONS TO THE CANDIDATES:**

- The same application will be considered for all the rounds of the counseling including MOP-UP round counseling.
- For complete details visit University website <http://ntruhs.ap.nic.in> and the candidates are advised to download Prospectus / Regulations and take a printout. Read these carefully to ensure your eligibility before applying.
- Candidates who have already applied for Competent Authority Quota Seats in response to this University earlier notification are also eligible for the management quota [Category B1, B2 & C (NRI)] seats, **but they have to submit separate online application** duly uploading the required scanned original certificates through <https://ugmq.ntruhsadmissions.com>
- The Application submitted only for Competent Authority Quota seats will not be considered for Management Quota seats.
- Candidates **possessing qualification of the University / Board of an institution outside the Andhra Pradesh State** should submit Equivalence certificate issued by the Board of Intermediate Education of Andhra Pradesh, to the effect that the qualification possessed is equivalent to or higher than the Intermediate examination conducted by the Board of Intermediate Education of Andhra Pradesh, at the time of admission in the College.
- Candidates **possessing qualification of the University / Board of an institution outside INDIA** should submit Eligibility / Equivalence certificate issued by Association of Indian Universities, New Delhi and also Equivalence certificate issued by the Board of Intermediate Education, Andhra Pradesh, to the effect that the qualification possessed is equivalent to or higher than the Intermediate examination conducted by the Board of Intermediate Education of Andhra Pradesh, at the time of admission in the college.
- Application and Processing fee including verification fee:** Rs.10,620/- (Rs.9000/-+ Rs.1620/-(GST)) plus Bank charges extra can be paid through Debit card / Credit card / Net Banking / UPI.
- The online application can be filled through any computer with internet connection or mobile with data connection. (**NOTE: preferably desktop or laptop**)

9. The Application and Processing fee including verification fee once paid will not be refunded or adjusted to a further date. The fee is non – refundable. Hence, candidates are advised to check their eligibility before applying.
10. The Provisional merit position will be displayed on the University website after verification of uploaded scanned original certificates.
11. Notification for exercising web options for admission into MBBS/BDS courses for the seats available under Management Quota (category B & C (NRI)) will be issued separately. Therefore, the candidates are advised to visit University website <http://ntruhs.ap.nic.in> regularly for further notifications.
12. The Candidates are hereby informed that if they have secured admission in medical colleges of other states, joined the course and if they are involved in blocking the seats under management quota in Dr. NTR UHS, the university will initiate legal action and same will be inform to the National Medical Commission for further course of action.
13. Online application form without uploading mandatory Certificates, Passport size photo, signature, incomplete information will be automatically rejected and will not be considered for determining the Merit position in respective categories using NEET-UG-2022 Rank.
14. The mere fact that the Merit position issued to the candidate does not imply that the candidature is accepted by the University and it does not mean that the entries made by the candidate in the online application are accepted as true and correct.
15. If the information furnished by the candidate in the application is incorrect or false or found fake and enclosed forged certificates / documents, during the admission process or later, then the University will take action that deems fit as per rules against the candidate including cancellation of seat, in case already admitted, without any notice. Further action against such candidate will be taken by the University.
16. Registration along with uploading of Scanned Original certificates will be permitted only once irrespective of the number of times of exercising web options / Number of counseling. No separate notification will be given for verification of original certificates. Therefore, the candidates should register and upload all the mandatory Certificates without fail.
17. Scrutiny of uploaded Original Certificates shall be done by the University and concerned departmental officials. After scrutiny of application and certificates the merit list will be released. Candidates are advised to watch the university website regularly for further Notifications/Instructions.
18. An in-eligible candidate obtaining Merit position does not make the candidate eligible for admission.
19. Seats in Un-aided Minority Medical Colleges are reserved for Muslim Minority Candidates only. In case Muslim Minority Candidates are not available the seats may be filled up with Non-Minority students during final Phase of counseling.
